It can just be a case of being overlooked, which is very common for black and older animals, but more often it is because they have specialised behavioural needs that a lot of people don't have the time for or experience to cope with.

Some animals have not been socialised when young so develop defensive and inappropriate behaviours towards people and sometimes other animals. Others have experienced a trauma, neglect or abuse in their past, which has knocked their confidence with people.

It can take a long time to gain the trust of these animals to be able to rehabilitate them so they can start to enjoy life and look for a new home. **As we are a non-euthanasia charity we never give up on a dog or cat** and strive to make their time with us as happy and as comfortable as we can.
